

Subject: Complaint for lodging F.I.R. case against the looter of riotous crowd numbering about 300 rioters who intentionally looted 1082 nos. of Gas cylinder including empty and refill from the Godown of M/s Misao Gas Service, Chingmeirong on 04.05.2023 in the morning at about 8-10 a.m.

Sir,

I, the undersigned, now serving as Manager of the M/s Misao Gas Service, Chingmeirong have the honour to make this complaint for lodging F.I.R. case against those looter who carried off the Gas cylinders from the Godown of M/s Misao Gas Service, Chingmeirong under the relevant laws and Acts.

1. That, on taking the advantages of the sudden breakout communal riot between the two communities of Kuki and Meitei in the state of Manipur, a large number of riot supporters broke down the godown gate of M/s Misao Gas Service, at Chingmeirong on 04.05.2023 in the morning at about 8-10 a.m. and the riotous crowds intentionally looted all the Gas cylinders kept in the Godown of M/s Misao Gas Service, at Chingmeirong as stock for supplying to the consumers. The details of the Gas cylinders kept in the Godown as per the stock register were all under:-

2. That, all the above mentioned Gas cylinders and regulators had carried off from the Godown by the riotous crowds. They also damaged the delivery vans parked in the Godown including two wheeler used by the officials. The details are as under:

- (i) MN06T 2220 (Maruti Suzuki)
- (ii) MN06T 2850 (-do-)
- (iii) MN06 SC 9990 (TVS two wheeler)

3. That, the rioters also damaged both office building and house of the proprietor so badly and took away many household items such as furniture, utensils, electronic items (microwave oven, T.V., a desktop computer).

I, therefore, under the above mentioned facts and circumstances most respectfully request that Hon'ble Sir to lodge F.I.R. case against the accused persons and kindly take up necessary action to recover the lost Gas cylinders mentioned above as the said items are the properties of the public.

I shall pray for your kindness.
