Sir,

I am to report that on 02-01-2023 at 11.30 am, received a written report from one Khundrakpam Rameshwar Singh S/o Kh.Kunjabihari Singh of Nachou Ward no 2 , that his elder brother namely Yanglem Priyobarta Singh (46) S/o Y Kesho Singh of Nachou Ward no 2 along with his four wheeler EECO Van Regd no MN01AS-7696 (grey in colour) had gone out of his house in the morning of 30-12-2022 at around 5.30 am and had not return home . The complainant had further reported that the mobile phone of the missing person having no 8974934821 could not be contacted since 31st dec 2022. And self have been endorsed to make an enquiry into the matter vide GD entry no 11/BPR -PS dated 02-01-2023.

In the course of the enquiry, the phone of the missing person is found switched off and that the missing person is a driver by profession owning an EECO van and plying mostly in Imphal Moreh route. A CDR of the mobile phone no belonging to the missing person was requisitioned. On examination of the family members of the missing person, it came to light that he had called his daughter on the night of 30-12-2022 at around 8.30 pm informing that he (the missing person) won't be returning home as he will be proceeding for a trip to Dimapur with one Heisnam James somewhere from Lamboi khongnangkhang, having phone no. 9362898181.

The said Heisnam James was contacted over his phone and he appeared at the police station on 04-01-2023 and he was examined. On his examination, he stated that he had spoken to the missing person over phone to go with him for a trip to Dimapur on 30th Dec 2022, which he had finally cancelled on the same day. So, he was let off on PR bond with instruction to appear as and when required. CDR of the missing person was received on 05-01-2023 and minutely examined. Spoken to all individuals which the missing person had last contacted and not much could be made out of it. However, some discrepancies in the statement of Heisnam James and the call records of the missing person was noted. So, Heisnam James was summoned .On 07th January 2023, at around 8.30 am, it is learnt that Heisnam James was picked up by a team of Irilbung Police Station in connection with a complaint vide GD no. 22/IBG-PS/2023 dt 04/01/2023. Contacted the officers of Irilbung PS to question him regarding the missing person, where he (James) made a confession to have murdered the missing person on the night of 30th December 2022. So, I immediately rushed to Irilbung PS and a detailed interrogation of Heisnam James was conducted and it is revealed that on 30th Dec 2022 at around 9.30 pm, Heisnam James had contacted the missing person (Yanglem Priyobarta) over phone and met him somewhere at Sagolband Tera and proceeded towards Mao on the EECO van of Priyobarta. He further revealed that James had stabbed Shri Y Priyobarta several times to death and left the body somewhere between Mao and Veswama .


So, Shri Heisnam James (31) S/o H Kumar Singh of Lamboi Khongnangkhang was arrested at Irilbung PS and a mobile handset and a wallet containing some id cards were seized from him observing formalities.


The arrested person and the seized items are therefore handed over to you for taking further necessary legal action against him (Heisnam James).
