Today i.e. 03/02/2023 at 8.55 pm, received an information that on the same day at about 8.45 pm, one TATA Tripper (white in colour) bearing registration No. MN01-9677 driven by unknown person coming from Khongnang Ani Karak side along NH-2 while taking U turn at the crossing of Nepali Basti, Chingmeirong along NH-2 collided with one two wheeler Suzuki Access 125 bearing registration No. MN06SG-3429 coming from the opposite side i.e from Sangakpham side towards Khongnang Ani Karak due to rash and negligent driving on the part of the driver of the TATA Tripper. As a result of which the rider of the Suzuki Access 125 got seriously injured on his head and body and also the Suzuki Access 125 caused partly damaged. Later, the injured person was evacuated to Shija Hospital for medical treatment.
