Today i.e 03/02/2023 at 9.20 pm received an information that on the same day at about 9.10 pm one Maruti Van bearing registration no. Nil driven by an unknown driver with an occupant coming from Shija Hospital side towards Lamphel and one Suzuki Swish bearing registration no. NL07M-6853 ridden by an unknown rider coming from Lamphel towards Shija Hospital side were collided each other near Home Guard office, Lamphelpat, due to rash and negligent driving and riding on the part of both driver and rider of the vehicles. As a result of which the driver and one occupant of the Maruti Van and also the rider of the Suzuki Swish received injury on their persons and evacuated to Shija Hospital, Langol for medical treatment. Both the vehicles got badly damaged.
