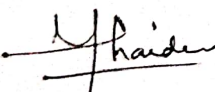

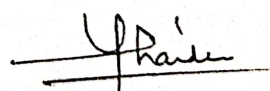

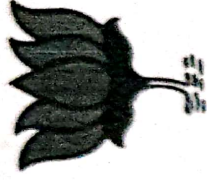

To The officer in Charge, Campd Police Station, Inghal West District.
Subject:— F.I.R.

Sir, I the undersigned have the honour to report you that today i.e. 9th Feb 2023 at about 9:10pm while BJP spokesperson Mayanglambam Suresh Singh, aged 35 years S/O N. Olin Singh of Kakching Khunou Hijam Manning Leikai, at present sampled Sama Keithel along with BJP office Secy Alex Ningsambam, aged 23 years S/O N. Ajtkumar Singh of Bamoun Leikai, Mangle Malchong were on their way along Camphel Langol Road on Renault car to drop Suresh at his rented house, 4 (four) persons under Mr. Popilal stopped them near the Tangkhul Church. The four persons grabbed down Suresh from the vehicle and started assaulting Suresh on his face and head. Suresh was fallen on the ground and kicked on his buttock and knee by their foot. In the meantime Alex tried to intervene them but Mr. Popilal pointed them by a gun and assaulted them. Their intention was to kill them but some vehicles came towards the spot. Then Mr. Popilal and his 3 (three) unknown associates fled away from the spot. Mr. Popilal used a face mask however he was clearly known by Suresh.

Mr. Suresh called me on my mobile phone and asked me to rescue them. Then, I along with some of BTYM members rushed at the spot and evacuated them to Raj Medicity. They are now under treatment in serious condition.

condition. You are therefore requested to take up necessary legal action against Mr. Popilal and his associates at an early date.
