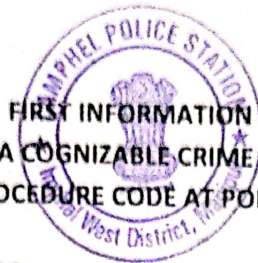





With due regards, I the undersigned have the honour to state few lines for your kind consideration and needful action.


