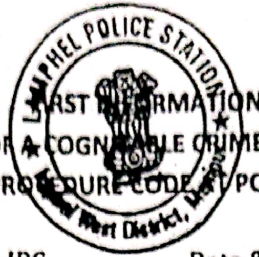



Sir,

I have the honor to lodge this report that today i.e. 10/02/2023 at about 7.00 am, one Krishnakanta Das (as we call him) about 50 years, husband of Smt. Thokchom Shanti Devi (Subhasini Devi Dasi), currently residing at Kongba Ucheckon came to ISKCON Temple, Imphal and suddenly attacked me from the back and in the scuffle, the said Krishnakanta Das has bitten me severely on the index finger of the right hand and struck my head against the wall of the temple in which I sustained severe injuries, all these happened while I was going to attend the daily darshan of the Deities. I was rushed to the RIMS hospital for treatment.

As such appropriate legal action may kindly be initiated against the said Krishnakanta Das by registering an FIR case for investigation and punishment for the offence he has committed and to prevent him from further commission of such crime in the future by causing his physical arrest. He has been disturbing the devotees of ISKCON Imphal since a long time. His mobile number is 7641032313.
