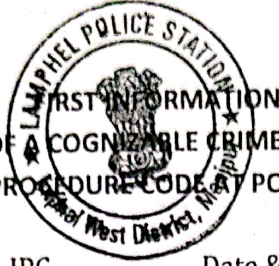

Sir,
With reference to the above subject and as per endorsement
I am hereby forwarding the report as under.

That on dated 10/02/2023 at about 7.30 AM, the
Complainant Mrs Thokchom Shanti @ Sobhasani age (52) yrs w/o
Krishnakanta Das of Changangei Uchekon Chongabi 1/W District
filed a written report to the officer in-charge Lamphal PS
stating that her husband namely Krishnakanta Das age
about (52) yrs (Executive member of ISKON) Temple has went for
daily Mangrati puja at ISKON temple located at Sangaepo.
That on the same day on Thiyam Sedubusan Das (priest
of ISKON Temple) and age about (70) yrs residing at the
Campus of ISKON had obstructed her husband for entering
at the said temple. In this regard, some altercation was
happened between them and suddenly the said Thiyam
Sedubusan Das had assaulted her husband inside
the temple by pushing his head to the pillar. As a result
of which her husband got severe injury on his head
and bleeding from the lower teeth and was evacuated
to Raj Medicity for medical treatment.

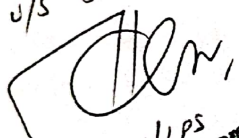
Accordingly the case was endorsed to me to look

10/02/2023, and I have been conducting enquiry, during
the course of enquiry, visited Raj medicity to examine
Krishnakanta Das (victim) however he was discharged from
the Hospital. In the meantime duly filled injury report
form in respect of Thokchom Krishnakanta Das (52) yrs c/o
Thokchom Shanti is submitted at Raj medicity hospital, located
at North AOC, further the complainant Thokchom Shanti was

that her husband was going medical treatment to
Delhi and further requested me to settle the matter
after returning back from Delhi.
