With due regard, I the undersigned have the honour to state few line for your kind consideration and needful action.

That, today i.e. on 23/02/2023 at about 3:00 pm, while I was at Children Park near Gynae Ward, RIMS hospital, Lamphel by trying to ring my family member for assistance after my wife delivery. Suddenly, one person namely Mujibur Rahaman @ Ibocha (40) yrs S/o Kora of Thoubal Keibung Sana Shibi Leirak and his associates numbering about 15 (Fifteen) had came towards me and started altercating with me regarding some money matter which I had no knowledge about it. At the same time, they started assaulting me severely from different angle. Moreover, my sister namely Sakhina (37) yrs w/o Apik of Hapta Golapati who tried to intervene on assaulting me by them had also been pushed forcefully by one Md. Rossan @ Roushan (33) yrs S/o Md. Nazibuddin of Hayellabuk Moirang Palli, Thoubal and one who name is not known. As a result of which, their assault I received severe injury on my face and other part of my body.

Therefore, I request you to kindly take necessary legal action against Mujibur Rahaman and his associates for their wild act. Thanking you for your kind co-operation.
