

Sir,

With due regard, I the undersigned have the honour to state few line for your kind consideration and needful action.

That, today i.e. 25/2/2023 at about 2:40 am, my younger brother namely Chonjonbam Monty told me that he heard some sound on the gate and informed that my Royal Enfield Continental GT-650 (Rocker red) bearing regd. Nil, worth Rs. 3,65,000/- (Three Lakhs Sixty Five Thousand) only was found missing which was parked at our Garage. I heard the sound of ignition of motor cycle. Immediately. I along with my two younger brothers ran toward the sound, which is about 100 meters from our gate. However, we could not caught the thief.

Later, I took the Alto Car of my uncle and chased the thief. On tracking the GPS location of my Continental GT 650, it is learnt that the location arises at Langthabal. On reaching Langthabal near PUC Ground, I saw my Motor Cycle, with a Alto car, red in colour, bearing regd. No. not known. When we reached near my motor cycle, the Alto Car brought by the thief fled away and the motor cycle got road misshaped. The thief was caught along with my stolen vehicle. He identified himself as Mustrak Pusham (21) yrs S/o Abdul Salam of Lilong Turel Ahanbi Dam Makha Maning Leirak, Thoubal District, Manipur. However, it is not possible to bring the thief and the stolen vehicle to Lamphel Police Station, the thief and stolen vehicle were handed over to Singjamei Police Station for safe custody.

Therefore, I request you to kindly take necessary legal action against Mustrak Pusham. Thanking you for your kind co-operation.
