Subject:- Report

Sir,

I am to state that on 25/02/2023 at about 12:10 pm a specific input received from 16th Assam Rifle about the movement of some armed militants suspected to be members of outlaw UNLF organization in General area of Langol Ningthou Leikai Imphal West Dist. On receiving the information a teams of Special Commando Unit, Khabeisoi led by Subedar L. Bebekananda Singh Officer-In-Charge Special Commando unit, Khabeisoi along with 1(one) women Police Constable namely Const. no. 1215030 W. Dushanti Devi of Women Police Station Porompat including myself, under the supervision of Shri Th. Krishnatombi Singh, MPS, Superintendent of Police/Railway & In-Charge Special Commando Unit, Khabeisoi rushed to the said area and started frisking operation in the area. During the search operation at about 12:30 pm while the commando teams surrounded some suspected houses, conducted house searched operation at Langol Ningthou Leikai Imphal West at the residence of Hamom Sunil Singh of Langol Ningthou Leikai Imphal West District. One woman was detained for verification. On verification she disclosed herself as Hamom Angoubi Devi Age about 40 yrs w/o Hamom Sunil Singh and house searched operation also conducted at the residence of Sagolsem Wangba Singh Langol Ningthou Leikai Imphal West District, Manipur another woman was detained for verification. On verification she disclosed herself as Sagolsem Roma Devi @ Abe Devi age about 43 yrs w/o Sagolsem Wangba Singh of Langol Ningthou Leikai Imphal West District, Manipur.

On further verification they disclosed that they are an sympathizer of the outfit UNLF organization, working under the command of 1(one) Mr. Leisangthem Sanayaima Singh of UNLF banned organization and their worked as a recruiting agent, recruiting minor age and they recruited 1(one) person from Heirok Thoubal District and handed over to one Mr. Leisangthem Sanayaima Singh age about 38 yrs S/o Leisangthem Chandrakumar Singh of Wangoo Tampha Lairembi Manak.

So, from the above facts and circumstances that they were arrested at the spot at 12:40 pm of 25/02/2023 and the below items were seized by preparing seizer memo at 12:45 pm. The arrested persons on body searched and seized the 2(two) mobile phone i.e.

- i) Celcor Key Pad (Dark green in colour) bearing Airtel Sim Card having Mbl no.6909257886 & BSNL Sim Card having no.9402264518 and IMEI no. i) 355259517215722 ii) 355259517215730.
- ii) Jio Mobile Phone Key Pad (Black In colour) bearing Jio Sim card having Mbl no.6009139709 and IME no.i)3582714101867799 were found from their possession.

The arrested persons and seized items are handed over to you for further legal action against them.
