Today i.e. 06/03/2023 at 11:40 pm, received information from MIKE-30, SP-IW control room on the same day 11:30 pm, one TATA Harrier (Black in colour) bearing registration No. MN01AW-4502 driven by an unknown driver coming from Khongnang Ani Karak side toward Sangakpham Bazaar collided each other with a two wheeler Aprilia 3V tech bearing registration no.
