In inviting a reference to the above subject, I am to state that on 2nd March, 2023, it has come to the notice of the undersigned from social media that the H.V.Logistics, P.O. Lamlong, P.S. Porompat, Branch Office - Senapati has been collecting money @Rs.2000/per Truck as Road Tax at Mao Gate from the vehicles carrying essential goods (potato, onion, garlic) plying from Guwahati to Imphal. A copy of Road Challan under memo no. 177 dated 28/02/2023 showing collection of Rs. 2000/- from vehicle No. NL-01AC-0380 is enclosed for reference.

That, H.V. Logistics, Nagaram Block-A, Laipham Siphai, Imphal East, Manipur-79510 was granted license for the business of collecting, forwarding and distributing potato, onion & garlic by the State Transport Authority (STA), Manipur initially for two years from 23/12/2017 to 22/12/2019 and further extended on three occasions (upto 22/12/2020, upto22/12/2022 & upto 312/12/2023) (copy of the license enclosed for reference).

As per the Rule 8 (f), the Licensee is not allowed to charge any commission exceeding that prescribed by STA, Manipur under Rule 10.

That, the above mentioned alleged collection of Tax by the Licensee from the good vehicles at Mao gate is illegal and without the knowledge of Transport Department Government of Manipur.

In this regard, it is requested to lodge an FIR against the H.V. Logistics, Nagaram Block-A, Laipham Siphai, Imphal East, Manipur-79510 at the earliest. Report taken may kindly be intimated to the office of the undersigned.
