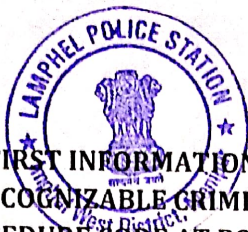

Today, i.e. 24/03/2023 at around 09:30 am, received an information that on the same day at about 09:00 am, one unknown person has entered the courtyard of the residence of Laishram Romeo Meetei (47 yrs) s/o Laishram Thoiba Meetei of Changangei Uchekon and took the axe which was kept inside the courtyard and attempted to attack everyone in the vicinity by using the axe. In which Laishram Basanta Meetei (43 yrs) younger brother of Laishram Romeo Meetei shot the unknown person by his license gun in order to save the life of himself, his family members and neighbours as there was no alternative means. As a result of which the unknown person succumbed to his injuries at the spot.

Hence, a Suo-Motu case is registered under FIR No. 56(3)2023 LPS u/s 304 IPC for investigation.
