Sir,

I have the honour to report that today i.e 26/03/2023 at 11.30 a.m a team of Traffic Control Police Wing led by myself, ASI Y. Priyobartan Singh of TCPW was conducting special drive at Changangei Makha Leikai along Tiddim Road, opposite Exit Gate of Imphal Airport. While performing duty one Activa 5G red in colour bearing redg. No. MN01AH/6524 ridden by one unknown rider without helmet coming from Malom side towards Keishampat was detained. On verification he identified himself as Shah Nawaz Khan (26) s/o Md Samseer Ali of Kwakta Khuman Bishnupur District. and he produced one vehicle registration Smart card of the said vehicle in the name of MD. Gayasuddin Khan s/o Abdur sttar of Phundrei Mayai Leikai, Phundrei Wangjing and One Adhar Card in the name of Shah Nawaz Khan, S/o Md. Samseer Ali of Kwakta Khuman Bishnupur District.

However, while on processing to issue e- challan slip for not wearing Helmet, it was found that the said vehicle was registered in the name of one Saikhom Johnson Singh s/o S. Shyamo Singh of Khangabok Makha Leikai, Thoubal District. On suspicion, further verification was conducted and during the verification, contacted the family of the registered owner Saikhom Johnson Singh and they stated that original vehicle is at their home. From verification it revealed that he( Shah Nawaz Khan) illegally used the vehicle number of the another vehicle and forged RC Card.

Hence, he was arrested at the spot at 11:40 a.m and seized the 1) one HONDA ACTIVA 5G red in colour Redg. No. MN 01AH6524 (2) One Adhar Card in the name of Shah Nawaz Khan, (3) One Smart card of Md. Gayasuddin Khan Phundrei Mayai Leikia, Phundrei Wangjing Thoubal,. (4) One Smart Phone Narza along with one Sim Card of Airtel, Sim no. 8991160900172075330, IMEI1. 864665052821613, IMEI2. 864665052821605 at 11.45 am by observing formalities from his possession.

The arrested person along with seized articles are handed over to you for taking necessary legal action against him according to law.
