With reference to the above subject, I am directed to state the following points for your information and further necessary action:

1. It has come to light recently that Shri T. Hemjit Singh, the then Mandol/L/A S.K./ L/A AS&SO, Directorate of Settlement & Land Records; Manipur a resident of Keisampat Leimajam Leikai, P.O./P.S. Imphal, Imphal West District had issued order for mutation of fake patta/jamabandi under patta No.639 covered by C.S. Dag No.265 measuring an area of 0.16 acre situated at revenue village No. 26/Wangkheirakpam Leikai in favour of Holi Spirit Catholic Church, Tribal Colony, Chekon vide his mutation case no.467/ASSO-IE-II dated 21.12.2018 by way of registered Sale Deed being No. 3224 (V) of Sub-Registrar, Porompat. Scan copy of fake Jamabandi/Patta (Cancelled & Un-cancelled) is also enclosed for reference.
2. In view of the above, it is requested that Shri T. Hemjit Singh, Mandol (Now under suspension) be booked u/s 420 and u/s 409 of the Indian Penal Code for his illegal activities and prosecuted accordingly.
