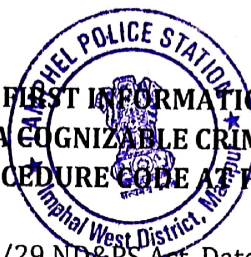





Subject: Report.

Sir,

I have the honour to report that today i.e., the 29<sup>th</sup> March, 2023 at about 1:40 p.m., while I was in my office of CDO/IE, one of my source man came and reported to me about concealment of illegal narcotics drugs at a medical store (pharmacy) at Lamphel Sana Keithel near AG Colony, Imphal-West, I recorded the statement of the source in writing and a similar copy of the statement dispatched to Superintendent of Police, Imphal-East through OC-CDO/IE. Without any delay, I along with teams of CDO/IE comprising of Woman Police personnel led by Inspt. Kh. Henery Singh, OC-CDO/IE assisted by ASI. Kh. Victor Singh of CDO/IE, ASI. Leipakchao Gangei of CDO/IE, ASI. Md. Sakir Ahamed and HC. N. Somorjit Singh of CDO/IE under the command of Shri Kh. Herojit Singh, MPS, Addl. SP(Ops)IE and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IE rushed to Lamphel Sana Keithel near AG Colony at around 2:20 p.m. after providing prior information to control room Imphal-West District Police. On reaching the said area, our source identified a shop and our CDO teams cordoned the area and raid a medical store (pharmacy) i.e., M/s Universal Pharma, which later identified that the said medical store belongs to one Shamulailatpam Rojina Devi.

In that, the CDO personnel detained one suspected man and the owner of the said medical store. On verification, the man identified himself as one Md. Riyajuddin, aged about 40 years, S/o (Late) Md. Joinullabuddin of Hatta Minuthong, Golapati, Imphal-West. On verification, the owner of the store identified herself as one Shamurailatpam Rojina Devi (39 years) W/o (Late) Gotimayum Priokumar Sharma of Kakching Sumak Leikai, Ward no. II, Kakching PS. A/p – Lamphel Sana Keithel AG Colony, Imphal-West District.

The team suspected that some narcotic and psychotropic items may be concealing in the medical store so, I told the detainees that their bodies, belongings and medical store needed to be searched. On being asked whether they would like to search before a Gazetted Officer or before an Executive Magistrate, in that, they stated that the search can be conducted by me (SI. Sukerjen Pangeijam) in presence of an Executive Magistrate and civil witness. Immediately, we contacted the office of the DM/Imphal-West District and accordingly deputed one Executive Magistrate namely Md. Zamilur Rahman, SDC(HQ)DC Office, Imphal-West. One civilian present there at spot is requested to witness the search of the shop and checking of their bodies and belongings.
