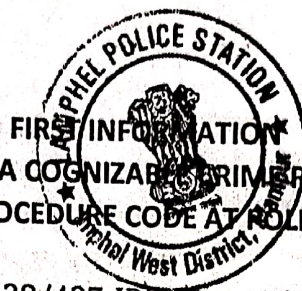

Today, i.e. 6/04/2023, at 12:30 am, received information from MIKE 30 SP-IW Control Room that a road traffic accident had occurred in front of NEXA Showroom at Chingmeirong, along NH-2 on the same day at around 12:15 am between one Toyota Fortuner Legender registration No. Nil driven by unknown driver along with 2(two) occupant coming from Chingmeirong towards Sangakpham had hit at the back of one Tata truck registration No. not known driven by unknown driver coming on the same direction, due to rash and negligent driving on the part of the unknown driver of Toyota Fortuner Legender. As a result of which the unknown driver and its two occupant of the Toyota Fortuner Legender had received injuries on their persons and evacuated to Raj Medicity for medical treatment. However, the Tata truck driven by unknown driver had fled away from the spot thereafter the accident and the Toyota Fortuner Legender got badly damaged.

Hence, a regular Suo-Moto case under FIR No. 62(04)2023 LPS u/s 279/338/427 IPC has been registered for investigation.
