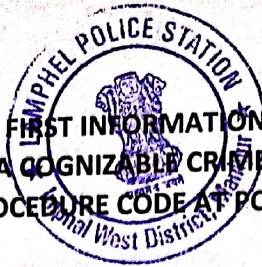

That on 12/04/2023 at about 7:30 am, one of our Client/Psychiatric patient namely Sarifa Akhtar (27) yrs of Bangladeshi National which was referred to our center namely Flamingo Mental Health care & De-Addiction for Women on 19/05/2022 vide File No. CSS-SW-703/1/2022-DSW-DSW, Department of Social Welfare Govt. of Manipur through Zingsho Rural Development Society Ukhrul Dist. vide reference no. ZRDS/MWCD/14/78 dated 2/6/2022 had absconded by jumping from the southern side of the center's campus wall located at Changangei Uchekon, Imphal west and did not return back till date.
