That, today i.e. 15/4/2023 in the intervening night in between 12:10 am to 12:40 pm, while my father namely Namram Nobin Singh (58) yrs S/o (L) N. Bukun Singh of Lamboikhongnangkhong along with mother Namram (O) Lata (52) yrs was returning from Takyel Khongbal road on foot after seeing Shumang Leela. Suddenly, one unknown vehicle (Car) driven by unknown driver had knock down both of them near PAL Office, Lamboikhongnangkhong, coming from Iroisemba side towards Imphal, along UK Road, due to rash and negligent driving on the part of the driver of unknown car and fled away towards Imphal side. As a result of which, my mother received injury on her body and my father received severe injury on his head and other part of his body and later evacuated to RIMS hospital for medical treatment.
