Sir,

I, will be highly obliged, if you kindly draw your valuable attention to the following few facts for your consideration and necessary prompt action.

That, my brother namely Mr. Paul Kahmei S/O Huthumang Kahmei a resident of Langol, Tarung near community hall gate, PO & PS-Lamphei, IW District Manipur was convicted and sentenced for 5 years and 6 months in c/w FIR No.9(9) 2017 TML PS U/S 354/307 IPC & 8/(H)(L)(R)/10 POC SO act 2012.

That, he has been released from the prison on 15<sup>th</sup> April 2023. He promised to kill our father and the witnesses who gave statements against him in the court after his release. Even after 5 years of imprisonment, he has not changed and still thinking to take revenge against the person who made the complaint (our father) and the witnesses who gave statements against him.

That, as he is released from the prison, he is looking for our father, the witness namely Mr. Meichunlung Gangmai and our brother-in-law namely Gaithailung Pamei and he is repeatedly saying that he will kill them all.

That, he also mentioned that he have friends in Manipur Naga Revolutionary Front (MNRF) who was his cellmate during his prison time and even plan to kill Ministers of Government of Manipur. He even told me to contact his MNRF friends which I denied.

That, today at around 11:30 am, he took out 2 knives from the bag and said he brings it from the prison and he will kill me. At that time my relatives namely Gangonglung Gangmei and Jessy Thaimiei snatched the knives from him and prevented from any unwanted incidents. The accused person was drinking alcohol since the morning. After the said incident he left and I saw him harassing and assaulting some students who were standing at the coaching centre gate at Langol Tarung. A lady tried to stop him from harassing the students at that moment he strangle the lady who tried to stop him. Thereafter, he went at the community hall, where a meeting was going on. There he challenged everyone and disrupted the meeting, he even tried to harm the people and their property by throwing bricks. As his act was so violent the people present there in the meeting detained him and bound him in a chair and locked him inside a room at the Langol Tarung Youth Club.

That, the accused person is very dangerous to the society and the people living around him.

In view of the above stated facts, your esteem office is requested to kindly registered in FIR and take legal action against the above mentioned accused person.
