Subject: Report

Sir, I am to report that today i.e, 24/04/2023 at about 7:30 pm received a credible information that Usham Rameshwor (34) S/o. Usham Jugindro Singh of Chingmeirong Maning Leikai, Imphal East a member of KCP (People War Group) terrorist organization is staying at his house, acting of the credible input with 16<sup>th</sup> AR. A special CDO team led by Officer in Charge Shri L. Bebekananda Singh assisted by SI KayelKumar Singh under the supervision by Shri Th. Krishnatombi SP/Railways and In Charge Special Commando Unit, Khabeisoi and immediate rushed at his house and conducted cordon and search. While conducting the cordon and search Mr. Usham Rameshwor Singh was found at his house and pick up for verification. On preliminary verification, he identified himself as Mr. Usham Rameshwor (34) S/o. Usham Jugindro Singh of Chingmeirong Maning Leikai, Imphal East an active member of KCP (PWG). He further disclosed that he joined KCP in the month of 2018 through one Mr. Kiran Singh of Thangmeiband Sinam Leikai. He further disclosed that he is working in finance section under the command of Lamyanba Khuman. He has collected about 1 Lakh from the hospitals and Clinic of the porompat side and handed over the same to Lamyanba Khuman as party fund of KCP( people war group). Hence he was arrested at 8:00 pm of 24/04/2023 from his house Chingmeirong Maning Leikai by preparing a formal arrest memo and seized 1(one) mobile (redmi 5g red in colour) phone and 1(one) adhaar card bearing adhaar No. 203713210723 from his possession also seized at 8.05 pm by preparing seizure memo.

The arrested person and seized items are hand over to you for further necessary legal action against him.
