



Today i.e. on 4th May, 2023 at about 2:00 pm, received a reliable information from SP-IW control room that on the same day at about 1.20 pm unknown Meitei agitators numbering about 700/900 of Meitei community consisting women folk of different age groups holding daos, spade, rode sticks, stones and other deadly weapons etc. coming from different direction had set on fire the "Green Valte" which is the house of Valte Hangkhalian, Ex-MLA, Churachandpur located at Lamphel Super Market. Due to such violent act of the unknown agitators the said house including private vehicle has been burn down and one person was also killed by them.

Hence, a suo motu case under FIR. No. 80(5)2023 LPS u/s148/149/452/436/302/427/506-IPC has been registered for investigation.
