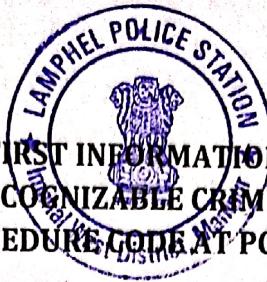



Today i.e. on 4th May, 2023 at about 9:00 pm, received a reliable information from SP-IW control room that on the same day at about 8.50 pm unknown agitators numbering about 300/400 of Meitei community consisting women folk of different age groups holding daos, spade, rode sticks, stones and other deadly weapons etc. coming from different direction had killed two unknown male persons at the IVR road of Chingmeirong Mamang Leikai near Hotel Classic Grande by restraining some unknown persons belonging to Kuki community who were hiding in order to save their lives on this prevailing communal crisis.

Hence, a suo motu case under FIR. No. 81(5)2023 LPS u/s 148/149/302/506-IPC has been registered for investigation.
