Today i.e. on 5rd May, 2023 at 2:30 pm, received an information from SP-IW control room that on the same day at about 1:50 pm, some agitators are coming towards Khongsai Veng side with intent to set on fire the Kuki inhabitate houses and business places etc. Immediately a combine team of police led by myself proceed toward the location.

On reaching at the Khongsai Veng, Imphal East, it is found that about 300/400 agitators of Meitei community consisting of men and women folk of different age groups holding daos, spade, rods sticks, stones and other deadly weapons etc. were pelting stones at the houses. To resolve the unlawful assembly and the riot, I announced to stop and disperse themselves within 5(five) minutes as per order of the District Magistrate. But the mob did not obey the command /order and became violent. As there is no alternative means I fired tear gas shell on them to control the riot. Later, it became under control and arrested 7(Seven) unknown agitators who took vital role at the riot for verification.

Hence a suo motu case under FIR. No. 84(5)2023 LPS u/s 148/149/506-IPC has been registered for investigation.
