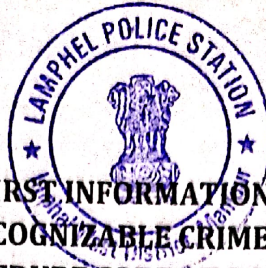



Subject – Report.

Sir,

With Due regard, I the undersigned have the honour to state few lines for your kind consideration and needful action

On 05 May 2023 at 3 PM we were moving from Langol to Game Village to evacuate some individuals in distress who had sent an SMS asking to be evacuated. While going to evacuate these persons we saw some individuals acting suspiciously near the Youth Club Building and small local Shop in Game Village. We evacuated the individuals (who had sent SMS) back to Langol and thereafter at 3:30PM went back to Game Village to check if there was any type of suspicious activity happening in Game Village. On our way back, near Youth Club we saw the same suspiciously acting individuals in the Youth Club Building. We had also received reports that large scale arson activity was going on in Game Village. So, we stopped near the Youth Club building where 09 unknown individuals were present. At approximately 3:40PM, we found the 09 unknown individuals with three weapons including one 12 Bore Double Barrel Rifle with three live rounds, one Air Rifle with scope, one Air Pistol. And after detailed search we also seized one x 200 Myanmar Currency note, INR 11,350 and 12 mobile phones with 2 power banks. Then we apprehended and brought the 09 individuals to Lamphel Police Station for handing over of these 09 unknown individuals and seized items to the Police authorities.

Therefore, I request you to kindly take necessary action against the individuals.
