Subject: Request to Register FIR against unknown persons for vandalizing of St. Joseph's Higher Secondary School, Sangaiprou Imphal

Sir,

I am to state that on 05 May 2023, around 03.00 PM a mob entered the campus of St. Joseph's Higher Secondary School, Sangaiprou Imphal and vandalized the school, presbytery, Convent, Boys Hostel, Girls Hostel, etc. With the suspicion of some mob attack and mob activity, the school authorities and occupants of the school were evacuated in the morning hours in the presence of the Superintendent of Police, Lamphel with the help of the DC, Imphal West.

At the time of the mob attack none of the inmates were around. Security cover was requested. A copy of the request letter is attached herewith for your perusal.

In the process of mob attack, the properties of the school, presbytery, convent and hostels including doors, windows, valuables, Camera DVR, Camera, etc. were destroyed and some lifted.

Attack on an institution considered the temple of learning and meant for the Educational Institution for the public at large irrespective of caste, creed, ethnicity, colour or race, is a sad precedence and need to be tackled so that it does not recur in the future.

I request that an FIR be registered in relation to the vandalization of the institution of public nature. I request the police to trace the culprits and deliver justice in the interest of the student community of Manipur.

Kindly provide me a copy of the FIR and along with the FIR No and other relevant documents.
