Sir,

I have the honour to state that on 8/5/2023 at about 2:30 pm, received information that some unknown persons have stolen the household items from the residential quarters of the Kuki Community of Langol Type-II area which was set ablaze by the agitators of the Meitei Community. Accordingly, a team of Lamphel PS led by me have rushed to the Langol Type-II area and conducted frisking & checking along with the Sikh Regiment deployed at the Langol area. During the frisking & checking, one Maruti Van (White in colour) bearing regd. No. MN1A-7572 loaded with wooden sofa on the top was coming from Langol Type-II residential quarter towards National Game Village driven by an known driver and co-driver. On questioning they identified themselves as 1) Shougaijam Robert @ Amuba (29) yrs S/o Sh. Raghu of Kakching Wairi Khullkpam Leikai A/p Thangmeiband Sinam Leikai and 2) Maibam Ashokkumar (24) yrs S/o M. Ningthem of Thangmeiband Sinam Leikai. They further stated that the furnitures were stolen from a residential quarter of Langol Type-II. However, they could not identify the quarter No. from where they have taken. Accordingly, both the accused persons were arrested by observing formalities in presence of witnesses at 3:10 pm and 3:15 pm respectively. Also seized 1) Maruti Van (White in colour) bearing regd. No. MN1A-7572 and its key, 2) One three-seater wooden sofa, 3) One wooden couch and 4) One wooden gas box at 3:20 pm by preparing seizure memo in presence of witnesses.

The arrested persons and seized items are handed over to the Police Station for further legal action.
