Sir,

I have the honour to state that on 8/5/2023 at around 4:30 pm, on received of an information from reliable source about the wrongful confinement of household materials to a house of one Arambam (o) Sangita Devi, 46 yrs. w/o A. Bhagat Singh @ Dudu of Langol Housing Complex Type-II and her unknown associates after stealing from the deserted family of Langol area due to this ongoing communal crisis by violating the curfew imposed by the District Magistrate-IW. I along with a team of Lamphel PS led by me had rush to the informed specific house given by the source and found a huge numbers of stolen household materials which were kept concealed at her house premise. Thereafter, she was arrested at 4.00 pm by preparing an arrest memo and seized all the household materials from the spot at 4.30 pm by preparing a seizure memo and also brought at Lamphel PS for further formalities.

Therefore, I request you to kindly take up necessary legal action against the arrested persons as per law.
