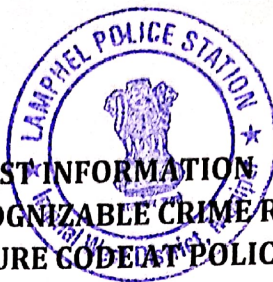

Sir,

I have the honour to state for kind consideration and necessary action that a combined team of 4/4 GR and police team of Lamphel PS led by me had conducted frisking and checking in c/w the prevailing law and order at Langol at Langol Game Village Zone-IV area today at 8.00 pm. While conducting frisking and checking, one unknown person was seen coming on a very suspicious manner at the said Zone-IV road by violating the curfew imposed by the District Magistrate-IW. On his suspicious nature he was detained and examined. On checking of his carry bag one Laptop was found kept decently and accordingly on examination to him he identified himself as Maibam Akash Meitei, 23 yrs s/o Late. So, he was arrested on the frisking place at 8.40 pm by preparing an arrest memo and the Laptop was also seized at 8.50 pm by preparing a seizer memo and later brought at Police Station for further formalities.
