



With due regards, I the undersigned have the honour to state few lines for your kind consideration and needful action.

That on 4/05/2023 at about 2:30 pm, some unknown agitators of the prevailing communal criess holding deadly weapons had trespassed the Meitei Presbyterian Church located at Sagolband Moirang Hanuba Leirak and set on fire our church building worth about Rs. 5,00,000/- as well as stolen the following amount and materials i.e a cash of Rs. 57550, Church Pulpit worth about Rs. 30,000, Chairman Table with wooden Chair worth about Rs.13,500, Secretary stand (leg turn) worth about Rs.6,000, Bench with arm 20Nos worth about Rs.1,20,000, Plastic Chair worth about Rs. 31,200, Almirah Wooden 3 Face worth about Rs. 50,000, Iron Godrej 2Nos worth about Rs.28,000, Fan 2Nos worth about Rs. 6,000, 3KVA Genarator yama BC worth about Rs. 32,000, Invertor with Battery worth about Rs. 25,000, Music item ( electric guiter,normal guiter,keyboard,Dulki,Church Drum ) worth about Rs. 68,000, Sound System ( 5 Feet speaker @nos. , 3mic, 3 stand, 1 mixture, 1 amplifier) worth about Rs. 1, 45,000 and other some small item worth about Rs.87,000.

Therefore, I request you to kindly take necessary action on the unknown agitators for their wild act. Thanking you sir for your kind co-operation.
