Respected Sir

I, the undersigned have the honour to state that out of sudden a number of unidentified mod who said to belong under Kuki community, carrying deadly weapon and sophisticate arms stormed against all Meitei's community vandalising and setting ablaze on entire houses and property in the locality along with my rented go-down in which my business goods were stored and robbed all items. In the unfortunate incident I have lost an asset which estimated around Rs 21 Lakhs caused by the violent mod. However, no casualties were occurred and my family flee under Myanmar relief camp, taking refuge for couple of weeks and now we have returned my resident on 7th August 2023, situated at Thambalkhong, Kongba Channam Leikai, Imphal East.

On the above statement I therefore prayed the authority to kindly initiate the matter against those culprits who have destroyed all the goods inside the rented godown and take action as per Indian Law against those who were involved in this heinous crime that let many homes and family suffers.

We are the residents of the above address since 2022 and have been staying on our rented house. On the 4th May, 2023, little did I know how bad exactly the situation was in Imphal other than the burning than the burning of churches and unending sound of tear gas in the night of 3rd May since the internet was shut down immediately. In the next morning we came to learned that our death was just a meter away from us. We started to collect and called all the helpline numbers we had. Our wishes was to reach any Army Camp and get shelter. We even called the Colonel of the Army but it was already late that the camp was already surrounded by the Meitei mobs and we couldn't go there anyway without strong security escort. He just told us to stay inside our locked doors. Group of the Meitei mobs came towards our colony checking each and house to torture
