I have the honour to report that today ie 19/8/2023 at about 1.30 pm my mother-in-law namely Ahat Golmei aged about 45 years w/o G. Athemei Kabui of Mahabali Kabui Khul was assaulted by one unknown person aged about 25 years at inside my mother-in-law bed room located at Mahabalu Kabui Khul while she was sleeping on her bed by using a pressure cooker without any knowing reason. As a result of which my mother-in-law was received seriously injured on her head, eye and some part of her body and she was evacuated to Kripadashini Advance Hospital Palace Compound for medical treatment.

It is, therefore, requested to kindly take up necessary legal action against the above mentioned accused person according to law.
