With due respect I have an honour to state that on 4/8/2023 at 12:00 Pm, It has come to my knowledge that my rented house (owned by Bimola Devi) located at Pureiromba, Konung Mamang, PS-Porompat, Imphal-East where the door lock had been forcibly opened without my knowledge and looted all my moveable household properties, important documents and 1(one) two wheeler Suzuki Access bearing No. MN06SB 1299 and vandalized the remaining properties by some unknown miscreants suspected to be from Meitei community. Approximate value of the loss properties is estimated to be Rs. 20,00,000/- (twenty lakhs).
