l am a retired Senior Accounts Officer (A & E) of the Principal Account General A&E, Manipur bearing Pension Payment Order (PPO) No. 630171900122 issued by the same department.

Lalong with my family numbering 2 Male and 6 Female reside at our Two-storey RCC building at Chassad Avenue, P.O-Imphal, P.S- Porompat, District-Imphal East, Manipur, bearing Patta No. 1406/1471 (Oid), 459 (New), measuring about .0380 Hectar, issued by the Directorate of Settlement & Land Record, Manipur.

I would like to reiterate that on 22nd May, 2023, miscreant mob of Meitei Community who were suspected to be instigated by Meitei Leepun and Arambai Tenggol of Valley based CSO, attacked, ransacked, looted and burnt my residential building as aforementioned above.

At the same time, one semi pucca residential building and another 1 storey semi pucca (wooden) residential house were also burnt and gutted down. Similarly, my car "A Star" bearing Regd. No. MN06L 6594, Engine No. 1701277, Chassis No. MA3EPDE1S00728119, Colour-Silver, Mfg-Maruti Suzuki was also torched and burnt.

Due to such attacked, being in state of vulnerability, fearing to lose our lives, I along with my family members had fled and now taking refuge at the residential house of my son namely D. Thangminlen Haokip at Na-Ang Village, Kaprang, P.O-Tollen, P.S & District-Churachandpur.

I, therefore, request to your kind office to intervene and register a complaint (Zero-FIR) against the perpetrators and abettor who commit such heinous crime against me and my family for the ends of justice.
