Subject :- **Report on Looting and burning of household items/assets**

Madam,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I **Thangjalal Guite** aged about 57 years H/o **Baby Guite** Belonging to the Any Kuki Tribe / Community, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am staying at Porompat Ward No. 2 PO/PS Porompat Imphal east.
2. That at about 11 am on the 20th May 2023, a huge contingent of armed radical meitei/Meitei suspected to be members of the Arambai Tengol and Meitei Leepun attacked our rented house at porompat Ward No.2 owned by Mr. N Premjit and so in order to save the lives of my family as well as myself I have to run for my life. And after me and my family left our house they have looted and vandalised my house .
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be **Rs. 500000 (Rupees Five lakhs) only**
4. Fortunately, I managed to escaped from the criminals who even tried to kill us, and now currently taking refuge at Lajangphai village Churachandpur.
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at Lajangphai village. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR , investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
