With reference to the above cited subject I have the honour to report to you as follows :

1. That I Kimdoiting aged about 38 years W/o S Kamginpao Vaiphei Belonging to the Vaiphei Tribe Community, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that my permanent address is New Lambulane 3<sup>rd</sup> street near Hmar veng Imphal East.
2. That at about 4 pm on the 21<sup>st</sup> June, 2023, a huge contingent of armed radical meitei/Meitei Mob suspected to be members of the Arambai Tengol and Meitei Leepun attacked our locality and in the process, they have looted my house .
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs. 6700000  
( Rupees Sixty seven lakhs ) only
4. Fortunately, I managed to escaped from the criminals who even tried to kill us, and now currently taking refuge at Compound Veng D.Phailen village Churachandpur.
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at Compound veng D Phailen village. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR , investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
