Subject - Report on Looting, Vandalism of household items/assets and Documents

Madam,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I Chinboi Haokip aged about 57 years W/o Mangkhokam Haokip Belonging to the Any Kuki Tribe / Community, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that I am a permanent resident of New Lambulane 2nd street near Eimi Times office Imphal - 795001
2. That at about 8 pm on the 5th of may 2023, a huge contingent of armed radical meitei/Meitei suspected to be members of the Arambai Tengol and Meitei Leepun along with Meitei Mob attacked our locality and in the process, they have looted and vandalized my house along with all my Documents and household items.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs. 8000000 (Rupees Eighty Lakhs) only.
4. Fortunately, me and my family managed to escaped from the criminals who even tried to kill us, and now currently taking refuge at Chengkonpang Darson enterprise Churachandpur.
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at Chengkonpang Darson Enterprise Churachandpur .And ,thus I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR , investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
