- 6. Fortunately, me and my family managed to escaped from the criminals who even tried to kill us, and now currently taking refuge at Chengkonpang Darson enterprise Churachandpur.
- 5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at Chengkonpang Darson Enterprise Churachandpur .And ,thus I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness. I shall always remain thankful to you and obliged.
