That, on the 29<sup>th</sup> <sup>May</sup> ~~June~~, 2023 at about 10:30 am my above said residence **Rented** was attacked, destroyed, looted and burned by a Group of Meitei/Meitei radicals.

These criminals broke/open my gate (s). destroyed and looted every valuable property from my **Rented** house, and premises worth **Rupees 8,00,000 (Approx.)** and they burnt down all the remaining things.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an FIR/Zero FIR under relevant sections of the statutes of our country.
