Subject: Reports of Vandalized and looting at 1st Street New Lambulane, Imphal East.

Dear Madam,

With regards to the above mention subject I, Neiboi Gangte age about 37 years d/o Luna Gangte, a staff nurse by profession working at Jawaharlal Nehru Institute of Medical Sciences(JNIMS) Imphal, a permanent residence of H/No.64. 1st Street New Lambulane, P.O. Imphal HQs & P.S. Porompat District Imphal East, presently staying in a rented house at Basan Phai, D. Phailian P.O.&P.S Churachandpur would like to inform and report that on the 3rd day of May 2023 at around 6:00pm while I was away for night shift duty at JNIMS hospital some Meeitei miscreant suspected to be led by Aramnai Tengol coming from Soibam Leikai, Imphal East start attacking tribal houses in the area of the above mention address including our house, which left us to fled for our own dear life.

Since, we have fled toward Lamka, Churachandpur our house as mention left unattended was looted and vandalize by the meeltei miscreant estimated to be at a value of about Rs.5,000,000/-(Rupees Fifty Lakhs only) which include of furniture, kitchen ware, electronic goods, gold ornament, cash note etc.

It may also be mention that all my document like Matriculation Certificate, Nursing Certificate, Bank Pass Book, Indian Pass Port etc were belief to be lost in this looting.

Therefore, I humbly pray that your kind office may take necessary action at the earliest for the end of justice for which I, will remain obliged to you.
