Subject: - Complaint/ Report on crimes of vandalism and looting of properties / discrimination of Scheduled Tribes.

Dear Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the **Paite Tribe**, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under the **SC/ST (Prevention of Atrocities) Act, 1989**.

That, due to the prevailing ethnic crisis in and around Imphal, I and my Family left our rental house owned by Phumkhangsong(8413019506) located at New Checkon, P.O. / P.S.- Porompat, District- Imphal East, on the 4th of May, 2023 at around 7:30 AM, and it has come to my knowledge that our deserted residence was vandalized and looted by a Group of radical Meitei/ Meiteis suspected to be members of **Arambai Tengol** and **Meetei Leepun** headed on the 10th of June, 2023 at around 3:00 PM.

That, while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because everyone, including top officials of the Manipur Government are patronizing them and that that no harm could be done to them.

That, the properties looted is estimated to be about **Rs.8,65,000.00/- (Rupees Eight Lakhs Sixty-Five Thousand)** only.

That, I am filing this information lately because there is a great danger to my life and due to which I was at different places like Bangalore to save my life and now I am able to restore my health and, thus I am filing the report lately today
