With reference to the above cited subject, I have the honour to report to your good office as follows:

That, I Mr Alex Thangminlun Hangzo aged about 37 years S/o (L) Khamkhenthang Hangzo belonging to the Paite Tribe, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, I would like to inform and register a cognizable offence carried against me and my family at our rented house located at Checkon, New Lambulane, Imphal East District. P.S- Porompat.

That, on the 10th of May, 2023 at around 11:00 AM, a huge contingent of armed radical Meitei/Meitei suspected to be members of the Arambai Tengol and Meitei Leepun attacked our locality and has looted our house taking away all the properties of the said deserted resident..

That, it may be reported here that above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated (approx.) to be **Rs 5,00,000 /-(Rupees Five Lakhs)** only.

Fortunately, me and my family managed to escaped with the help of Central Forces from these criminals who even tried to kill us, and now currently taking refuge at Lower Chapel Lane, Hiangtam Lamka P.O. & P.S. Churachandpur, Dist. Churachandpur, Manipur.

I am filing this report lately since I have been at different places for safety. Now, since I am able to settle myself at the above mentioned address, I am in a position to file a report today. Hence, prayed that my report be accepted.

In the given circumstances, I humbly pray you to kindly register a **ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of the land. And, for which act of kindness, I shall always remain thankful to you and obliged.
