Madam,

With reference to the above cited subject, I have the honor to report to you as below:

1. That, Chinhat Haokip age 40 w/of (L) Tongkhohao

belongs to the KUKI Community, a Schedule Tribe recognized under the Constitution of India. By Virtue of which I am entitled for protection under The SC/ST (Prevention of Atrocities) Act, 1989. Whereby, I had stayed at a Rent at Haokip Veng, Imphal P.S. Parompat District Imphal East

2. That, on 4th May 2023 at 11^{NOON} AM/PM, a huge contingent of armed Radical Meeitei/Meitei Mobs, Arambai Tengol and Meeitei Leepun along with State Forces like Manipur Police Commando and Indian Reserve Battalion (IRB) attacked our village, and in the process looted/vandalized/burnt my house/properties.

3. That, the above said Criminals with their inhumane activities have grave caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be Rs 87,00000 (Eighty seven lakhs) Only

4. Fortunately, me and my family narrowly escaped from these Criminals who even tried to kill us.

Henceforth, we are taking refuge at B. Aijalon (Relative's Residence), Ccpur

I, therefore, request you to register an FIR/ZERO FIR and bring justice.
