These criminals broke/open my gate (s). destroyed and looted every valuable property from my **Rented** house, and premises worth **Rupees 2,45,000/- (Approx.)** and they looted all the remaining things.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an FIR/Zero FIR under relevant sections of the statutes of our country.
