That, I would like to inform and register a cognizable offence carried against me and my family at our rented house located at New Checkon,Imphal East, P.O-Imphal & P.S-Porompat.

That, on the 4th of May, 2023 at around 10:00 AM, a huge contingent of armed radical Meeitei/Meitei suspected to be members of the Arambai Tengol and Meetei Leepun. attacked our locality and in the process, they broke the gate/door open, looted and vandalized the properties including all my Educational Original documents of class-X certificate bearing Roll. No. 3441 and Class xii certificate bearing Roll No. 1892 from the said deserted resident.

That, it may be reported here that above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated (approx.) to be Rs 5,00,000,00 (Rupees Five Lakhs) only.

Fortunately, I managed to escaped from these criminals who even tried to kill or burn us alive, and now currently taking refuge at T.Lhangnom, P.O. & P.S. Churachandpur, Dist. Churachandpur, Manipur.

In the given circumstances, I humbly pray you to kindly register a ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of the land. And, for which act of kindness, I shall always remain thankful to you and obliged.
