Akampat, Imphal East District, Manipur.

It is therefore requested to your goodself to kindly initiate necessary
action against the accused person/culprits involved in the said human rights
heinous crime Committed by them as per law of the land at the earliest.

I shall be very grateful for your kind co-operation and necessary action
the matter please with warm regards.
