Whereby, I had stayed at a Rent at Habkip Veng P.S Portom part District mphal East 2.That, on 4/5/2023 at 11 AM/PM, a huge contingent of armed Radical Meeitei/Meitei Mobs, Arambai Tengol and Meeitei Leepun along with State Forces like Manipur Police Commando and Indian Reserve Battalion (IRB) attacked our village, and in the process looted/vandalized/burnt my 3. That, the above said Criminals with their inhumane activities have grave caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be Rs 78 Lakhs 5K 4. Fortunately, me and my family narrowly escaped from these Criminals who even tried to kill us. Henceforth, we are taking refuge at B.
