Dear Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the Gangte Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, due to the prevailing ethnic crisis in and around Imphal, I along with my family left our rented house owned by Kam pu Haokip (9612476360) located at 44-Bethel Home, 1st floor, 2nd Street, New Lambulane, P.O.- Imphal, .P.S.-Porompat, District- Imphal East- 795001 on the 5th of May, 2023 at around 10:30 AM, we escaped for our lives, taking refuged at 86th Battalion, Central Reserved Police Force (CRPF), Lamphel where we stay for about 5(five) days, it has come to our knowledge that our deserted residence was attacked and looted by a Group of radical Meitei/ Meiteis suspected to be members of Arambai Tengol and Meetei Leepun on the 29th of July, 2023 at around 01:00 PM and I would also like to add that the said looted properties was looted parts by parts.

That, the looted properties is worth about Rs.29,50,000 /- (Rupees Twenty-Nine Thes suport is se- (mater) as

That, due to the reason of transferring from one camp to another, I am filing that report lately after reaching Churachandpur dist.
