Sub: Complaint on attempt to Murder and Racial Discrimination against Kuki/Zo, a tribal minority in Manipur by a dominant Meitei Community.

Sir, With reference to the above cited subject, I have the honour to report to you as follows.

1. That, I am a scheduled tribe belonging to Kuki tribe which is a recognized tribe under the constitution of India, by virtue of which I am entitled to the protection under the SC/ST Act 1989.

That, I am a student of Manipur University, Canchipur, PO/PS-Singjamei, Imphal West and staying in a rented house at New Lambulane 2nd Street near Grace Dental clinic, Checkon Imphal West.

2. That, On 3rd of May, 2023 at about 7 PM the Meeteis/Meitei radical suspected to be members of the Arambai Tenggol and Meitei Leepun where all over the streets in search of people belonging to Kuki tribe.

3. Around 2:30 AM hundreds of suspected members of Arambai Tenggol and Meitei Leepun with arms shouting at the particular community i.e Kukis to come out from our rent house with a slogan "Kuki Hatlo".

4. That, it may be reported here that the miscreants were shouting slogans "Kangleipak Yaiphare", "Kuki Hatlo", "Hao Hatlo" etc. On being fear for our lives we deserted our belongings and rented room leaving behind all our belongings. The total value of loss/damage properties is about Rs 2 Lakhs.

In the given circumstances, I humbly pray you to kindly register FIR and investigate the matter and punish the perpetrators as per the prevailing provisions of the law of the country and for this act of kindness I shall always remain thankful to you and obliged.
